# 1st National Photography Art Exhibition

## 2025 NPAE Rules and Regulations

- 1 The exhibition is organized to promote photography art and in conjunction with the celebration of the Singapore 60th National Day (SG60).
- 2 This exhibition is co-organized by the Society of Photographers Singapore (SPS) and the Safrat Content Creator Club (SAFRA-CCC).
- 3 The National Photography Art Exhibition has two categories, club-nominated and open submissions.
- 4 Each organizing and supporting organization may nominate up to fifteen (15) excellent members, each submits one (1) photo.
- 5 **Open submissions** will go through a selection panel. Each participant can submit only one (1) JPG image. JPG image requirement: High-resolution photograph at least 3,000 pixels on the longest side, maximal file size of 5 MB.
- 6 **Open submissions**, download the NPAE registration form, and submit to sg.npae@gmail.com, together with a JPG image cloud-sharing portal link (such as WeTransfer, Google Drive, or Dropbox).
- 7 The theme of the photography art exhibition, all entries must have been taken in the last 60 years, depicting the development of Singapore in lifestyles, landscapes, nature, and others.
- 8 Submissions must include the location and year in which the photo was taken.
- 9 Upon receiving the acceptance notice, a registration fee (Including exhibition print and mounting fees) of S\$30 for each entry can be paid to SPS PayNow (UEN): T16SS0217L or Bank Transfer to SPS Maybank Account: 4141088954.
- 10 After payment, for the organizer to keep records, please email the bank transfer slip or paynow payment screenshot to council.sps@gmail.com
- 11 All entries must originally be from a camera or smartphone. Only basic editing that does not distort its original form is allowed. AI and/or computer-generated images are not accepted.
- 12 Watermarks are not acceptable. The entry will be disqualified.
- 13 Participants must own the full copyright to the entry submitted.
- 14 The participant permits the organizer to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition.
- 15 The photograph must not, in the sole and unfettered discretion of the Sponsor/Organizer, contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.
- 16 Participants who enter into this exhibition have agreed to release his or her particulars to the organizer and its working partners including sponsors, for the purpose of identification and contractibility.
- 17 If there is any incompleteness in these regulations and rules, the organizer has the right to add, delete, or revise them.
- 18 All participants are deemed to have agreed to accept these regulations.
- 19 The closing date for the two categories of submission is 30 June 2025.
